#### **Christopher Pugliese**

Director of Housing Development, Affordable Housing Alliance

Christopher Pugliese joined the Affordable Housing Alliance (AHA) as Director of Housing Development in June 2021. He oversees all current and future affordable housing initiatives.

Previously, he served as Project Director at Conifer Realty for six years, where he successfully implemented and completed the development process for over 600 affordable homes across New Jersey, Philadelphia, and Westchester County, NY. He contributed to expanding affordable housing with the City of Long Branch Housing Authority, and serves on the Board of Trustees for the Supportive Housing Association of New Jersey. In addition, he has served as an instructor for Rutgers University's Housing Authority Executive Director Certification Program, demonstrating his commitment to sharing expertise in the field.



#### Jonathan Sternesky, Ph.D.

Director of Policy & External Affairs, New Jersey Housing & Mortgage Finance Agency Dr. Jonathan Sternesky is the Director of Policy and External Affairs at the New Jersey Housing and Mortgage Finance Agency (NJHMFA), where he provides policy analysis, develops programs to

advance the Agency's mission, and promotes awareness of its accomplishments. During his tenure, NJHMFA has achieved historic investments in affordable housing, established a permanent funding source for special needs housing, and supported landmark legislation. Previously, Jonathan served as East Brunswick's Economic Development Officer and Legislative Director in the New Jersey General Assembly. He is an adjunct professor, a member of his local Zoning Board, and holds a B.A. from Kean University, an MPA from Seton Hall, and a Doctorate in Public Administration from West Chester University.
